Interpretation

- 1** For the purposes of the Act and this Regulation, a passenger conveyor is designated as an elevating device.

Declaration of Standard in force

- 2** CSA Z98-14, Passenger ropeways and passenger conveyors, published in March 2014 by CSA Group, as amended from time to time, is declared in force in respect of passenger ropeways and passenger conveyors.

Variations

- 3** Despite any note or other text in CSA Standard Z98-07, Passenger Ropeways and Passenger Conveyors, the Standard is varied by declaring Annexes A, C, D, E, F, G, H, J and K and any references to those annexes in the Standard as mandatory.

Paramountcy

- 4** If there is a conflict between CSA Z98-14, Passenger ropeways and passenger conveyors as declared in force in this Regulation and the *Elevating Devices, Passenger Ropeways and Amusement Rides Permit Regulation* (AR 286/2002), that Regulation prevails over the Standard.
