- Provides comprehensive safety services including permits, inspections, training, design review and public education through a variety of organizations.
- Maintains "Accredited Agency" status in the Elevator discipline.

 It is accredited by the Safety Codes Council of Alberta to provide in-service inspections on all classes of elevators and lifts on a competitive basis.

Governance and Accountability:

We are advised by an eight-member Board of Directors, representing all industrial sectors we regulate, as well as a Ministerial Appointee. Message from the

Chief Executive Officer

It is hard to believe it has been 20 years leading this organization. When I started, we had 6,000 elevating devices and twelve staff. Today we have thirty staff, and the same amount of Administration staff managing approximately 19,000 elevating devices.

Technology and online payments have enhanced our team's efficiency. It has been a busy year in all our disciplines. Some Highlights from this year's operational plan include:

Stakeholder Engagement

AEDARSA has actively engaged with various stakeholders to ensure the safety and efficiency of elevating devices, amusement rides and passenger ropeways across Alberta. This includes consultations, seminars, education sessions and meetings with our various stakeholders:

- AEIS (Alberta Elevator Industry Seminar): Two-day seminar in Edmonton was held to discuss safety standards, compliance, and future initiatives to enhance safety protocols.
- Passenger Ropeway Meetings: Collaborative sessions with stake holders to communicate safety standards, maintenance and operating requirements including industry trends and incident reports.
- Amusement Ride Meetings: Engaged with Amusement Ride operators to review safety standards, maintenance and operating requirements including industry trends and incident reports.

Risk Management

AEDARSA continues to prioritize and evaluate our business operations to allow us to enhance and develop policies in the areas of Information technology, human resources, and insurance.

Record Applications and Increased Activity

The Delegated Administrative Organization (DAO) has never been busier, particularly in southern Alberta, with record applications for new and altered elevating devices being submitted daily. *AEDARSA* has worked tirelessly to keep up with this trend, ensuring that all applications are processed efficiently and in compliance with safety standards.

Technology Advancement and User Access oNe and oNeX

- Hundreds of hours have been spent developing our own app for AEDARSA oNe and oNeX and
 is being used in the Amusement Ride and Passenger Ropeway disciplines.
- The app is being assessed for security and should be ready for rollout at AEIS 2025 in Calgary.

Mentorship and Hiring Initiatives

To address the increasing demand and maintain high safety standards, *AEDARSA* has implemented several key initiatives:

- Mentorship of Level 2 Safety Codes Officers: Experienced officers have been mentoring new Level 2 Safety Codes Officers, providing them with the necessary training and guidance to perform their duties effectively.
- Hiring of Level 1 Safety Codes Officers: To keep up with the volume of in-service inspections,
 AEDARSA has hired additional Level 1 Safety Codes Officers. This has enabled us to maintain
 rigorous inspection schedules and ensure the continued safety of all elevating devices.

AEDARSA remains committed to ensuring the safety and reliability of elevating devices, amusement rides and passenger ropeways across Alberta.

None of this would be possible without an excellent team of resolute employees working hard to make sure Alberta is the "Gold Standard" for DAO's.

The AEDARSA board of directors remains committed to ensuring AEDARSA has the resources to maintain our safety focus at the same time using technology to our advantage.

Our Services

AEDARSA's services fall under two categories.

Delegated Services

These are regulated services that AEDARSA is exclusively mandated and authorized to perform by the Government of Alberta. Delegated services vary by discipline, but include reviewing and approving construction plans, conducting final construction inspections, issuing of construction and operating permits, completing investigating and reporting on all safety-related incidents.

AEDARSA is also mandated to provide Technical Advice and Education to industry stakeholders, to keep the industry apprised of changes to safety codes and regulations. (To learn more, see page 24.)

Accredited Agency Services

These inspection services are specific to in-service inspections on elevating devices. They can be provided by any company or organization that is accredited to perform these services. AEDARSA provides these services on a competitive basis, and given our experience and expertise is the market leader. (See page 25).

Core Programs & Goals

Most of AEDARSA's core programs are delegated administrative functions. The exception is AEDARSA as an Accredited Agency, which competes with other Agencies to provide in-service inspections on elevating devices. All programs are intended to promote the safety of persons in their use of and contact with elevating devices, amusement rides and passenger ropeways (ski lifts).

All Delegated Programs have met the performance measures.

Delegated Services

Incident Reports and Investigations (all disciplines)

All incident reports received by AEDARSA are evaluated to determine if an investigation may be required. Investigations are conducted when there is any indication that safety equipment, devices or procedures should have prevented the occurrence. The goal is to determine the cause of the incident and to prevent re-occurrences.

215 Incident Reports

Reports Received and Evaluated

The AEDARSA office received 215 incident reports over the past operating year.

This resulted in on-site investigations involving reported injuries, equipment damage, or any indications that safety issues might continue to occur due to faulty equipment.

Incidents Reported Were Related To



Elevating Devices Investigation Results Summary

There were 176 incident reports received resulting in 80 onsite investigations. Five (5) were classified as serious or fell into the serious injury category (required medical treatment), but no fatalities.



Passenger Ropeways Investigation Results Summary

Thirty-five (35) incident reports were received resulting in 2 onsite investigations. Zero (0) were classified in the serious injury category (required medical treatment), but no fatalities.



Amusement Rides Investigation Results Summary

There were 16 incident reports received resulting in 1 onsite investigation, with zero (0) classified in the serious injury category (required medical treatment), but no fatalities.



Delegated Services

Elevating Devices

Functions, Activities & Performance Measures



Delegated Services

Annual permits of operation are issued in accordance with Alberta Regulations. They are used for tracking purposes in relation to current addresses and owners of new and existing devices and their operational status. Permit-related records are constantly updated based on information received in an effort to ensure the accuracy of data used for subsequent notifications about safety inspections required. This is done in accordance with applicable provincial policies and regulations, to validate the permits issued.



Safety Inspection Notices Issued, Inspections Recorded

AEDARSA ensures that safety inspections (in-service inspections) on existing installations are carried out as recommended by the Safety Codes Council. This is every two years on most elevators and yearly on certain elevating devices such as escalators, barrier-free lifts and manlifts. These in-service inspections are required annually on amusement rides and passenger ropeways that operate in the province.

For manageability purposes and to provide opportunities for cost savings to owners in rural centres, *AEDARSA* issues inspection notices in batches to building owners in specific areas of the province in three-month intervals (January, April, July and October). To provide ample time to make necessary arrangements, owners are provided three months to complete the in-service inspections by an agency before *AEDARSA* begins follow-up actions to obtain inspection reports that have not yet been received.

Inspection Notices were issued requesting in-service inspections for 10,674 devices between April 1 and March 31.

On overdue inspection(s), follow-up actions are implemented commencing 15 days after their due date.

Permits of Operation were issued to Owners or Managers of 10,227 buildings, authorizing the operation of 18,431 elevating devices.



Plans Review

AEDARSA reviews design plans for all proposed new installations and major alterations of existing equipment. This is done to ensure that qualified professionals design the equipment. In addition, the plan review ensures that designs comply with the most current applicable Alberta Regulations and/or provincially adopted safety codes.

This is accomplished through *AEDARSA'*s design review program and subsequent issuance of Permits of Construction & Major Alteration.

Acceptance Inspections Performed

AEDARSA conducts acceptance inspections and tests of new and altered installations prior to their being placed into service or returned to active service. This program is intended to provide reasonable assurance that devices are installed in accordance with accepted plans, applicable codes and regulations.

Applications for Special Inspections (Elevators)

The category of Special Inspections captures all elevator inspection-related work that does not appear on the permit list. This includes inspections related to cab enclosures, door replacements and more. Over the past year of operations, AEDARSA received 311 applications for Special Inspections, performing 555 in total.

Passenger Ropeways

Application for Permits of Operation were sent to 38 Passenger Ropeway Operators, with 150 lifts in Operating status.

Permits of Operation were issued to 37 Passenger Ropeway Operators covering 150 ski lifts that were operated within the province.

Safety Inspection Notices Issued, Inspections Recorded

AEDARSA ensures that safety inspections are carried out as recommended by the Safety Codes Council. These safety inspections are required annually on passenger ropeways.

Plans Review

AEDARSA reviews design plans for all proposed new ski lifts and major alterations of existing ski lifts. This is done to ensure that qualified professionals design the ski lift. In addition, the plan review ensures that designs comply with the most current applicable Alberta Regulations and/or provincially adopted safety codes.

This is accomplished through AEDARSA's design review program.



Acceptance Inspections Performed

AEDARSA conducts acceptance inspections and tests of new and altered ski lifts prior to their being placed in service or returned to active service. This program is intended to provide reasonable assurance that the ski lifts are installed in accordance with accepted plans, applicable codes and regulations. The inspections ensure that all safety equipment and devices function properly, in accordance with codes – and that proper installation practices have been followed.

There were 7 acceptance inspections performed this year.

Passenger Ropeways – Delegated In-Service Inspections

As part of our Delegated In-Service Inspections, *AEDARSA* inspected the procedures and records of 37 Passenger Ropeways Operators and inspected 150 ski lifts in total.

These safety inspections are required annually on amusement rides.
